ST. CROIX TRIBAL COUNCIL RESOLUTION NO. 11-08.2021.02

RESCINDMENT BANISHMENT OF ANTHONY BRYCE LAFONTAINE FROM ST. CROIX CHIPPEWA LANDS

WHEREAS, the St. Croix Chippewa Indians of Wisconsin (Tribe) is a federally recognized Indian Tribe duly organized under Section 16 of the Indian Reorganization Act of 1934, 25 U.S.C. § 476, as amended, and established pursuant to the Constitution and By-Laws adopted by the Tribe on August 29th, 1942 and approved by the Secretary of the Interior on November 12, 1942; and

WHEREAS, pursuant to Article IV, Section 1 of the Constitution, the governing body of the Tribe is the Tribal Council (the "Tribal Council") the duly elected governing body of the St. Croix Chippewa Indians of Wisconsin has the authority and responsibility of making decisions on behalf of the Tribe to protect the public health, safety and welfare of the Tribal Members; and

WHEREAS, Article V, Section 1(d) authorizes the St. Croix Tribal Council to remove from Tribal lands, non-members whose presence or activity may be deemed injurious to the welfare of the Tribe; and

WHEREAS, the St. Croix Tribal Council previously found the activity of non-member, Anthony Bryce Lafontaine, DOB: 11/07/2003, with a last known address of 24684 W Hertel Drive, Hertel, WI 54893, injurious to the welfare of the Tribe and enacted Tribal Council Resolution No. 10.13.2021.01 "Banishment of Anthony Bryce Lafontaine from St. Croix Chippewa Lands"; and

WHEREAS, the Tribal Council intends to now rescind the aforementioned resolution in its entirety, but reserves the right to review this decision and/or issue a secondary banishment resolution for Mr. Lafontaine in the future;

NOW THEREFORE BE IT RESOLVED, that the St. Croix Tribal Council hereby rescinds Tribal Council Resolution No. 10.13.2021.02.

BE IT FURTHER RESOLVED, that this resolution be forwarded to the St. Croix Tribal Police Department and St. Croix Housing Authority for further action.

CERTIFICATION
