## ST. CROIX TRIBAL COUNCIL RESOLUTION NO. 02.06.2027.01

## LIFT OF BANISHMEN OF DARRELL D. TAYLOR (AKA DARYL TAYLOR JR.)

WHEREAS, the St. Croix Chippewa Indians of Wisconsin (Tribe) is a federally recognized Indian Tribe duly organized under Section 16 of the Indian Reorganization Act of 1934, 25 U.S.C. § 476, as amended, and established pursuant to the Constitution and By-Laws adopted by the Tribe on August 29th, 1942 and approved by the Secretary of the Interior on November 12, 1942; and

WHEREAS, pursuant to Article IV, Section 1 of the Constitution, the governing body of the Tribe is the Tribal Council (the "Tribal Council") the duly elected governing body of the St. Croix Chippewa Indians of Wisconsin has the authority and responsibility of making decisions on behalf of the Tribe to protect the public health, safety and welfare of the Tribal Members; and

WHEREAS, Article V, Section 1(d) of the Constitution and By-Laws of the Tribe grants the Tribal Council the authority to remove from Tribal lands, non-members whose presence or activity may be deemed injurious to the welfare of the Tribe; and

WHEREAS, the Tribal Council found the activity of non-member, Darrel D. Taylor, AKA Daryl Taylor Jr., injurious to the Triba and ordered his banishment from Tribal lands via Tribal Council Resolution No. 17.12.06.01; and

WHEREAS, the Tribal Council granted a conditional lift of his banishment via Tribal Council Resolution No. 2020.02.11.01 for the purposes of visiting his grandfather and obtain services; and

WHEREAS, Darrel D. Taylor did attend a membership meeting on February 6, 2023 and did request a lift of his banishment due to being sober for over two (2) years and generally turning his life around; and

WHEREAS, at the membership meeting on February 6, 2023 a majority of those members in attendance did vote affirmatively to lift the banishment of Darrel D. Taylor;

NOW THEREFORE BE IT RESOLVED, that banishment of Darrell D. Taylor, AKA Daryl Taylor Jr. is lifted and Tribal Council Resolutions. 17.12.06.01 and 2020.02.11.01 are hereby rescinded.
